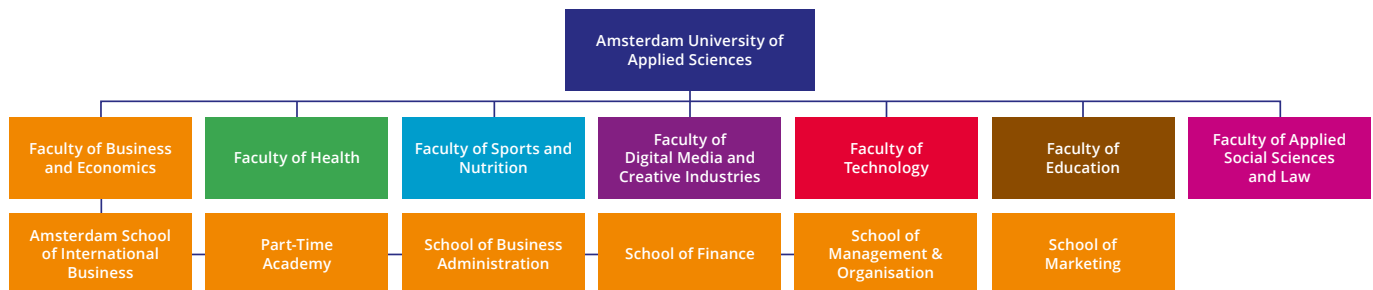




## Faculty of Business and Economics
